Youth Education Guidelines

Maximum Match Available:	6 months - \$3,000 13 months - \$6,000 25 months - \$9,000
Minimum Savings Amount:	\$25.00 per month

REQUIREMENTS

- Expenses are paid directly to an eligible educational institution.
- The institution must either be an accredited college/university or vocational school.
- Participant must be between ages 14 and 24 upon enrollment.
- May not change assets.**
- If a saver decides not to continue saving for education and has received trust fund money for their account, the money will go back into the trust fund account.
- May not be able to do emergency withdrawals, depending on the source of the fund (trust fund).
- Participant must sign below to acknowledge understanding of these guidelines.

What education costs are eligible?

- Tuition and fees
- Course fees
- Books and supplies
- Test fees
- Cost of courses for preparation for professional licensing examinations
- Equipment, including a computer and software
- Tutoring, SAT Prep classes, and GED classes
- Rent
- 529 College Savings Accounts
- Any expense being paid directly to the school

Payment documentation (other items that must be provided to our staff before funds are released, appropriate to the purchase):

- Tuition bill from the school or training program
- Description of degree program or course of study (a course catalogue may be acceptable)
- Estimate or bill for education expenses
